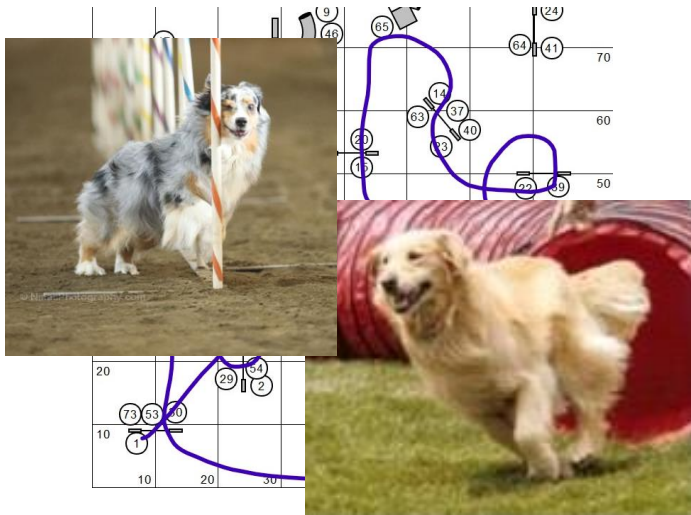


TWO MEGAN FOSTER AGILITY SEMINARS DECEMBER 8, 2018
